## Risk-based approach to Reduce Aircraft Ground Damage

**Overview:** The classic iceberg shows that numerous near misses result in an accident. Without a proper hazard identification, risk mitigation and root cause analysis, the accident will recur. This masterclass unveils the practical approach taken to gain intelligence and drive change. Case studies used will highlight the value of conducting operational and GSE risk assessments. It will also provide insight on how to conduct effective investigations and identify root causes.
